SUBMITS respectfully the said annexes as underseal available only to the Presidency;

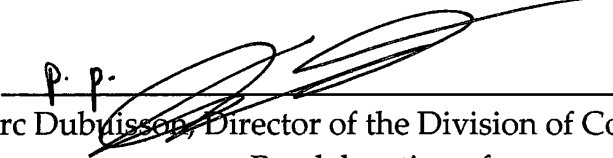
