Should Mr. Mugambi be admitted to the List of Counsel, he will be acting as an Associate Counsel, otherwise, if admitted to the List of Assistants to Counsel, he will be acting as Legal Assistant to the team. Should he not meet the qualifications for admission to both lists, he will be acting as case manager for the team ensuring the defence of Mr. Muthaura.
