NOTING paragraph 8 of the "Decision setting a time-limit for the submission of new victims' applications for participation" dated 7 September 2010;¹

NOTING that on 8 April 2011, the Trial Chamber III (the "Chamber") instructed the Registry to transmit applications received before 1 February 2011, together with as many applications as the Registry is able to process in the time available by 21 April 2011;²

NOTING article 68(3) of the Rome Statute, rule 89(1) of the Rules of Procedure and Evidence and regulation 86(5) of the Regulations of the Court;

CONSIDERING that 401 applications for participation received in the present case have been processed and redacted in accordance with the guidelines established by the Chamber;³

CONSIDERING that the Registry will transmit these applications in redacted form to the parties and the legal representatives of the applicants in accordance with the Chamber's instructions;⁴

CONSIDERING that the Registry will also prepare and transmit to the Chamber an individual report for each of the applications annexed to this report;
