NOTING the “*Order on numbering of evidence*” (“Trial Chamber’s Order”) publicly filed by the Trial Chamber on 12 May 2010;¹

NOTING the Notification email from the Registry to the Chamber, parties and participants in the Lubanga case on 14 June 2010 (“Registry email”);²

NOTING the “*Requête de la Défense aux fins de reconsidération de l’ordonnance de la Chambre de première instance I portant le numéro ICC-01/04-01/06-2432, datée du 12 mai 2010*”, (“Defence application”) confidentially filed by the Defence on 11 October 2010;³

NOTING the “*Prosecution’s Response to the Defence’s “Requête de la Défense aux fins de reconsidération de l’ordonnance de la Chambre de première instance I portant le numéro ICC-01/04-01/06-2432, datée du 12 mai 2010*”, (“Prosecution’s response”) publicly filed by the Prosecution on 2 November 2010 ;⁴

NOTING the “*Decision on the defence request to reconsider the “Order on numbering of evidence” of 12 May 2010*”, (“Trial Chamber’s Decision”) publicly filed by the Trial Chamber on 30 March 2011;

NOTING the article 64(9)(a) and (10) of the Rome Statute; rules 15, 63(2) and 64 of the Rules of Procedure and Evidence; regulations 28 and 53 of the Regulations of the Registry;

CONSIDERING that the Chamber in its Decision determined the following:

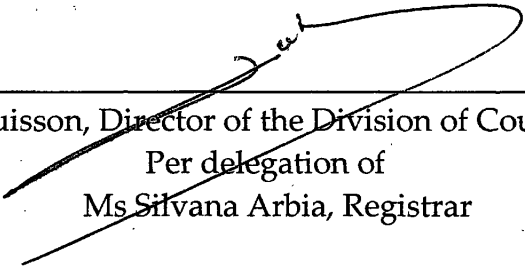

- a) that the documents listed in footnote 31 are to be removed from the Record;
- b) that the EVD numbers assigned to documents MFI-D-00017 and MFI-D-00071 in their entirety are to be corrected so as to refer only to the excerpts set out in paragraph 22 of the Decision;
- c) that MFI-D-00086 and MFI-D-00136, MFI-DOI-00137 and MFI-D-00138 are to retain their current EVD numbers;
- d) that MFI-D-00121 and MFI-D-00130 are to be assigned new prosecution EVD numbers. The previously assigned defence EVD numbers are to be deleted;
- e) that MFI-D-00166 and MFI-D-00168 are to retain their current EVD numbers.

SUBMITS as follows:

- 1) the EVD status, and numbers previously assigned to the documents listed in footnote 31 have been removed;⁵
- 2) the EVD numbers, and ringtail entries assigned to documents MFI-D-00017 and MFI-D-00071 in their entirety have been corrected to refer only to the excerpts set out in paragraph 22 of the Trial Chamber's Decision;
- 3) EVD status and numbers of MFI-D-00086 and MFI-D-00136, MFI-DOI-00137 and MFI-D-00138 remains the same;
- 4) MFI-D-00121 and MFI-D-00130 are hereby assigned EVD-OTP-00681 and EVD-OTP-00682 respectively.⁶ The previously assigned defence EVD numbers have been removed;
- 5) EVD status and numbers of MFI-D-00166 and MFI-D-00168 remains the same.
