The Registrar of the International Criminal Court ("the Court"):

NOTING the *Corrigendum of the "Decision on the Confirmation of Charges"* dated 7 March 2011¹ (the "Decision");

NOTING Article 5(1)(b)(i) of the Relationship Agreement between the International Criminal Court and the United Nations;

NOTING Article 87(1)(a) of the Rome Statute and Rule 176 of the Rules of Procedure and Evidence;

CONSIDERING that Pre-Trial Chamber I instructed "the Registrar to notify the [...] Decision to (i) the UN Security Council; (ii) the Host State authorities; and (iii) the Sudanese authorities";

INFORMS the Chamber as follows:

Notification to the UN Security Council

1. The Office of Legal Affairs of the United Nations was transmitted the Decision on 11 March 2011.
2. On 22 March 2011, the Under-Secretary-General for Legal Affairs of the United Nations acknowledged receipt of the Decision.

Notification to the authorities of the Host State

3. The authorities of the Host State were notified the Decision on 11 March 2011.

Notification to the Sudanese authorities

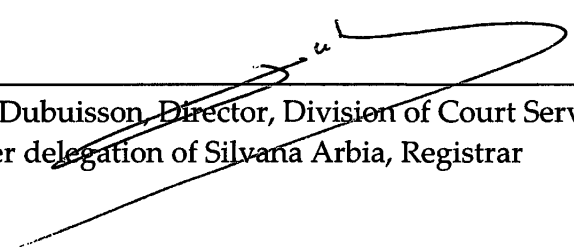
