THE REGISTRAR of the International Criminal Court;

NOTING the decision of Trial Chamber III, dated 9 December 2009,¹ in which the Chamber decided that the Office of the Public Counsel for Victims shall represent those victim applicants who have not chosen a legal representative until a decision is made on their application to participate;

NOTING the decision of Trial Chamber III, dated 19 November 2010,² recalling that applicants who have either not chosen a legal representative or mentioned in their applications their willingness to be represented by the OPCV are represented by the OPCV until a decision is made on their application to participate;

NOTING the Ninth transmission to the Trial Chamber of applications for participation in the proceedings³ and the Ninth transmission to the parties and legal representatives of the applicants of redacted versions of applications for participation in the proceedings, dated 21 April 2011;⁴

CONSIDERING that the following 334 applicants listed in annex 1 and transmitted to the parties and Trial Chamber III on 21 April 2011 do not have a legal representative or have expressed their willingness to be represented by the OPCV;

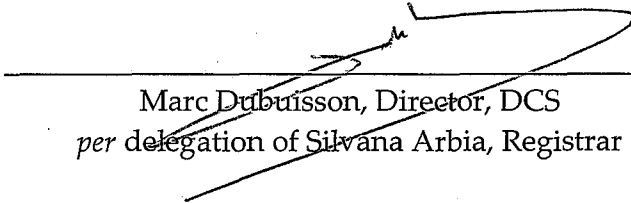
