THE REGISTRAR of the International Criminal Court (the “Court”);

NOTING the oral ruling issued by the Trial Chamber on 1 April 2011 in open session (“Chamber’s oral ruling”) instructing that all documents admitted in evidence, currently only carrying pre-trial EVD numbers, are to be issued trial EVD numbers;¹

NOTING the *“Registrar’s Report on various outstanding EVD related matters”*, (“Registrar’s report”) publicly filed by the Registrar on 04 May 2011;²

NOTING that documents DRC-OTP-0029-0275³, and DRC-OTP-0029-0274⁴ were initially assigned EVD-OTP-00697, and EVD-OTP-00696 respectively, and later inadvertently further assigned EVD-OTP-00726, and EVD-OTP-00727 respectively in Annex A of the Registrar’s report;

NOTING that in addition to the contents of Annex A of the Registrar’s report, there are more documents initially issued EVD reference during pre-trial phase, and subsequently admitted during the trial phase without receiving a trial EVD reference;⁵

NOTING the Trial Chamber’s oral instruction during the proceeding of 7 May 2010⁶ regarding the assignment of an EVD number to document DRC-D01-0003-2478;⁷

NOTING article 64(9)(a) and (10) of the Rome Statute; rules 15, 63(2) and 64 of the Rules of Procedure and Evidence; regulations 28 and 53 of the Regulations of the Registry;

SUBMITS as follows:

- A) that documents DRC-OTP-0029-0275, and DRC-OTP-0029-0274 will retain reference: EVD-OTP-00697, and EVD-OTP-00696 respectively, while EVD-OTP-00726, and EVD-OTP-00727 will now be assigned to documents DRC-OTP-0014-0140, and DRC-OTP-0087-0275 respectively,⁸
- B) in public Annex A, more documents initially issued EVD reference during pre-trial phase, and subsequently admitted during the trial phase without receiving a trial EVD reference are assigned new Trial EVD numbers,
- C) that document DRC-D01-0003-2478 will now be assigned the reference: EVD-D01-01101.
