THE REGISTRAR of the International Criminal Court (the "Court"),

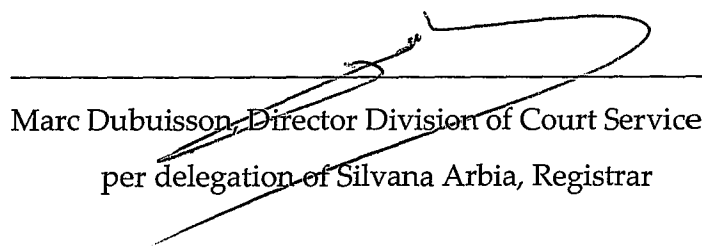
NOTING the status conference of 20 May 2011;¹
