NOTING the testimony of Prosecution expert witness DRC-OTP-WWWW-0358 on 13 May 2009;¹

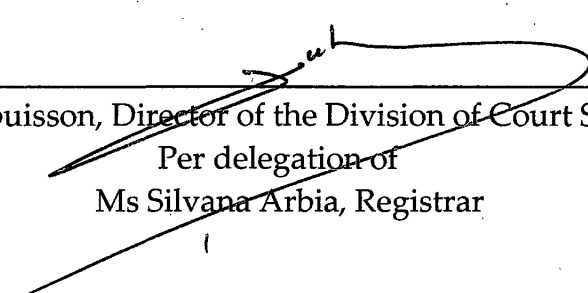
