1. On 31 May 2011, the Prosecution filed the Prosecution's request for variation of time limit and fourth application for redactions to witness statements pursuant to Rule 81(2) and Rule 81(4) ("Fourth Application").<sup>1</sup>
2. Two sections of transcripts of witness statements were inadvertently omitted in the annexes to the Fourth Application: one from Annex 1 and the other from Annex 2. Further, the requested redactions were only identified by yellow highlights, instead of yellow and blue highlights. The Prosecution resubmit these annexes with the complete transcripts of the witnesses' interviews and the corrected highlights, consistent with the redaction charts.<sup>2</sup>
3. Some proposed redactions were identified through highlights in the statements but were not captured in the redaction charts. Conversely, some proposed redactions were identified in the charts but not through the highlights to the statements. The Prosecution resubmits Annexes A and B to the Fourth Application with the appropriate corrections.<sup>3</sup>
