PRE-TRIAL CHAMBER III of the International Criminal Court (the “Court”) issues the following Decision on the election of the Presiding Judge of the Chamber.

1. On 22 June 2011 the Presidency of the Court constituted Pre-Trial Chamber III and assigned the situation in the Republic of Côte d’Ivoire to the Chamber.¹
2. The Presidency temporarily attached Judge Odio Benito and Judge Fulford to the Pre-Trial Division.²
3. The Presidency constituted Pre-Trial Chamber III as follows:
 - Judge Odio Benito
 - Judge Fulford
 - Judge Fernández de Gurmendi.³
4. On 27 June 2011 Pre-Trial Chamber III met to elect a presiding Judge, pursuant to regulation 13 (2) of the Regulations of the Court.

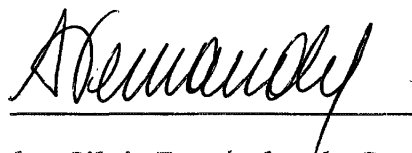

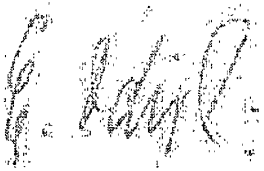
THE CHAMBER HEREBY,
