1. On 13 July 2011, the Single Judge issued the “Decision on the Defence Requests in Relation to the Submission of a Comprehensive In-Depth Analysis Chart”, in which the Single Judge ordered the Prosecution to submit, by no later than Monday, 1 August 2011, a comprehensive in-depth analysis chart of the evidence included in the list of the evidence upon which the Prosecution intends to rely for the purposes of the confirmation of charges hearing, wherein each piece of evidence is linked to each constituent element of the crimes charged, and, wherein each piece of evidence concerning the alleged criminal responsibility is presented with respect to each suspect separately.¹
2. In compliance with this Decision, The Prosecution hereby submits a comprehensive in-depth analysis chart, appended hereto as Annexes A - E.
3. The Prosecution requests that these Annexes be received by the Single Judge as “Confidential”, as they contain information of a sensitive nature not currently available to the public and/or which was obtained from confidential sources.
