FOR THESE REASONS,

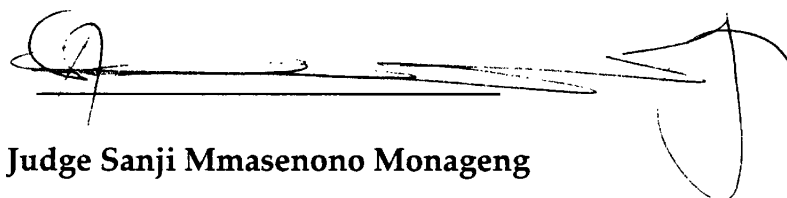
