The Presidency of the International Criminal Court;

Noting the complaint of the *Association pour la Promotion de la démocratie et du développement de la République Démocratique du Congo, association sans but lucrative* (“Aprodec asbl”) against the Registrar for alleged misconduct pursuant to article 46 of the Rome Statute (“Complaint”);<sup>1</sup>

Noting the Decision of the Presidency dated 1 December 2010 (“Decision”) which determined the Complaint to be manifestly unfounded;<sup>2</sup>

Noting that by internal memorandum dated 16 December 2010, the Presidency indicated to the Registrar that although, ordinarily, any such complaint must remain confidential, as Aprodec asbl had initially filed certain documentation related to the Complaint with a public classification, prior to it being reclassified as confidential,<sup>3</sup> if the Registrar wished the Decision to also be filed publicly she could communicate such desire to the Presidency;<sup>4</sup>

Noting the response of the Registrar, also by internal memorandum, dated 22 December 2010, confirming that she wished the Decision to be made public and that she also wished that document ICC-RoR221-01/10-3-Conf be filed publicly;<sup>5</sup>

*Hereby*

Orders that the Registrar reclassify ICC-RoR221-01/10-3-Conf as public; and

Orders that the Decision be rendered public by its inclusion as Annex I hereto;

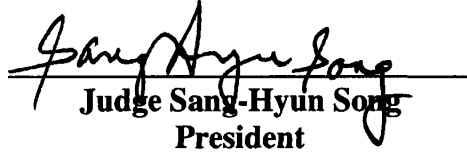
