The Registrar of the International Criminal Court ("the Court")

NOTING the Prosecutor's public notice of 17 June 2011 providing notice to victims from Côte d'Ivoire of his intention to request authorisation to open investigations and informing them that pursuant to regulation 50(1) of the Regulations of the Court, they have 30 days to make their representations to the Chamber;¹

NOTING the Presidency's Decision constituting Pre-Trial Chamber III ("Chamber"), and re-assigning the situation in Côte d'Ivoire;²

NOTING the Prosecutor's Request for authorisation of an investigation pursuant to article 15 of the Rome Statute dated 23 June 2011;³

NOTING the Chamber's Order of 6 July 2011 instructing the Victims Participation and Reparations Section to submit, by 1 August 2011, a single, consolidated report on the collective and individual representations received with the original representations annexed thereto;⁴

NOTING the Registry's Request for an extension of time to report on victims' representations pursuant to regulation 35 of the Regulations of the Court,⁵ and the

Chamber's Decision on the Registry's Request dated 28 July 2011, extending the deadline for filing its report to 29 August 2011;⁶

NOTING the Registry's Report to Pre-Trial Chamber III on victims' representations received from victims from Côte d'Ivoire ("Registry's Report");⁷

NOTING the Chamber's Decision pursuant to article 15 of the Rome Statute on the authorisation of an investigation into the situation in the Republic of Côte d'Ivoire dated 3 October 2011;⁸

NOTING the Prosecution's Request for reclassification of Annexes 1 to 1089 of the Registry's Report on victims' representations ("Prosecution's Request");⁹

NOTING the Registry's observations on the Prosecution's Request dated 10 October 2011;¹⁰

NOTING the Chamber's Decision on the Prosecution's Request for reclassification of Annexes 1 to 1089 of the Registry's Report on victims' representations dated 17 October 2011 ("Chamber's Decision");¹¹

NOTING articles 15 and 68(1) of the Rome Statute, rules 50(1) and (3), 85 and 89(1) of the Rules of Procedure and Evidence and regulations 23*bis* and 24*bis* of the Regulations of the Court ("Regulations");

CONSIDERING that the Chamber, in its Decision, ordered the Registry to reclassify Annexes 1 to 1089 to the Registry's Report as *ex parte*, "Registry and Prosecution only" pursuant to Regulation 23*bis* (3) of the Regulations by 24 October 2011, unless the Registry considers that there is need for specific redactions and is unable to meet the said deadline, and that in such a case, the Registry shall revert to the Chamber by 4p.m. on 19 October 2011;¹²

CONSIDERING that the Registry does not consider that redactions need to be applied to the aforementioned annexes;

RECLASSIFIES hereby Annexes 1 to 1089 to the Registry's Report as *ex parte*, "Registry and Prosecution only" in compliance with the Chamber's Decision.
