NOTING Trial Chamber III’s decision dated 10 November 2010 authorizing the Registry to designate two common legal representatives from the Central African Republic to represent the totality of the victims allowed to participate in the present case;¹

NOTING the Registrar’s filing dated 18 November 2010 designating Mr Assingambi Zarambaud and Ms Marie Edith Douzima Lawson as legal representatives for all victims participating in the present case;²

NOTING Trial Chamber III’s decision dated 15 December 2011 granting participating status to 404 applicants (“Decision of 15 December 2011”);³

NOTING article 68(1) of the Rome Statute; rules 90(2) to 90(5) of the Rules of Procedure and Evidence and article 16 of the Code of Professional Conduct for Counsel;

CONSIDERING that no conflict of interest has so far arisen in the representation of victims allowed to participate in the present case and that article 16 of the Code of Professional Conduct for Counsel obliges legal representatives to ensure that no such conflict arises and, in case of difficulties or objections raised by a victim, to

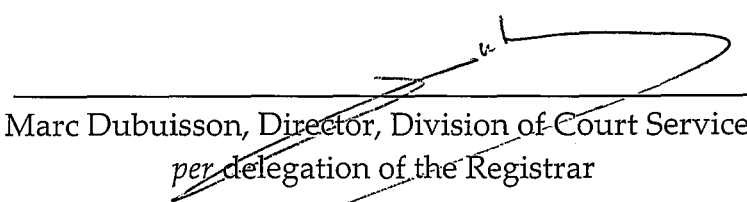
