1. Pursuant to an order¹ by Pre-Trial Chamber I (“Chamber”), the Prosecution hereby submits certain documents referred to in the Prosecutor's Application under Article 58 of the Rome Statute, filed on 2 December 2011, wherein it sought an arrest warrant against Abdel Raheem Muhammad **HUSSEIN** (“Prosecutor’s Application”).² The Prosecution also explains whether any of these documents have been previously filed in the situation in Darfur.
2. The Prosecution attaches herewith, as Under Seal, *ex parte*, Prosecution Only Annex A, a list of the documents requested by the Chamber, together with corresponding explanatory notes; and as Under Seal, *ex parte*, Prosecution Only Annexes B1-B28, each of the supporting documents requested by the Chamber.

3. The Prosecution requests that Annex A and Annexes B1-B28 be received as “Under Seal, *ex parte*, Prosecution Only”, as they relate to material submitted in support of the Prosecution’s Application that was so classified, and to which victim and witness protection considerations apply.
