The Registrar of the International Criminal Court (the "Court");

NOTING Trial Chamber III's ("Chamber") decision issued on 22 February 2010 ordering that complete applications for participation in the proceedings that appear, *prima facie*, to be linked with the charges confirmed against the accused be provided to the Chamber ("22 February 2010 Decision");¹

NOTING the order of the Chamber, conveyed by email on 16 September 2010, that applications for participation in the proceedings received by the Registry be transmitted to the parties in redacted form on an ongoing basis as and when they are prepared, and in accordance with the guidelines on redactions provided in the 22 February 2010 Decision;²

NOTING the order of the Chamber, conveyed by email on 26 August 2010, that in relation to all future applications the Registry should systematically notify the respective legal representatives of the applicants of the redacted versions of applications as notified to the parties;³

NOTING the Chamber's decision issued on 8 July 2011 setting the date of 16 September 2011 as the final deadline for the submission to the Registry of any new victims' applications for participation in the trial;⁴

NOTING the instruction of the Chamber, conveyed by email on 2 September 2011, that the Registry transmits any pending applications in batches of 200 to 350 applications on a continuing basis;⁵

NOTING the Chamber's Order conveyed by email on 16 February 2012⁶ that the Registry file certain applications for participation⁷ in the present case which were referred to in the Registry's Confidential Report of 3 June 2011;⁸

NOTING article 68(3) of the Rome Statute, rule 89(1) of the Rules of Procedure and Evidence and regulations 23 *bis*, 24 *bis* (2) and 86(5) of the Regulations of the Court;

CONSIDERING that the annexes are filed with the status "Confidential *ex parte*, only available to the Registry", in order to sufficiently protect the identity of the applicants and their intermediaries when applicable;

CONSIDERING that 308 applications for participation received in the present case have been processed and redacted in accordance with the guidelines established by the Chamber;⁹

CONSIDERING that the Registry will transmit these applications in redacted form to the parties and the legal representatives of the applicants in accordance with the Chamber's instructions;¹⁰

CONSIDERING that the Registry will also prepare and transmit to the Chamber an individual report for each of the applications annexed to this report;

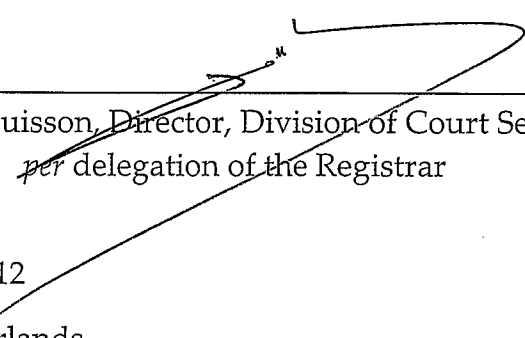
