NOTING rule 13(1) of the Rules of Procedure and Evidence ("RPE") and regulations 23 *bis* and 24 *bis* of the Regulations of the Court;

CONSIDERING that on 1 June 2012 at 14h09, Mr. Kaufman communicated to the Court Management Section on behalf of Aisha Gaddafi's, a document, with two confidential annexes, to be filed before Pre-Trial Chamber I (the "Chamber") in the Libya situation and referred as follows:

"Aisha Gaddafi's request for information relating to the Prosecutor's investigation of the murder of Muammar Mohammed Abu Minyar Gaddafi"

CONSIDERING that on 1 June 2012, Mr. Kaufman was informed by the Associate Legal Officer, Courtroom Officer in charge that the footer was referring to the case and not to the situation although the documents were to be filed in the situation;

CONSIDERING that on 3 June 2012 at 10h44, Mr. Kaufman communicated to the Court Management Section on behalf of Aisha Gaddafi's, a corrected version of the above mentioned document, with two confidential annexes, to be filed before Pre-Trial Chamber I (the "Chamber") in the Libya situation;

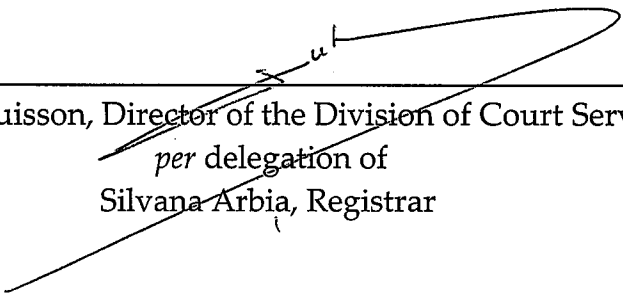
CONSIDERING that the documents communicated on 1 June 2012 at 14h09 were notified on 4 June 2012;

CONSIDERING the role of the Registry as the Court's channel of communication under rule 13(1) of the RPE;

CONSIDERING that by transmitting the above mentioned document, the Registry does not express any views regarding the status of the applicant which remains to be decided by the Chamber;¹

CONSIDERING that the above mentioned document may contain sensitive and confidential information, it is therefore submitted as confidential *ex parte* only available to the Registry and to Mr. Kaufman;
