1. In order to keep the Chamber informed of the disclosure of incriminating evidence, and in compliance with the Order¹ to provide it with access to these materials, the Prosecution herewith submits its communication of the disclosure of incriminatory evidence pursuant to Article 61(3)(b) of the Statute to the Defence.
2. On 3 September 2012, 29 items were disclosed². Discrete redactions have been applied to meta-data fields to protect the identity of OTP investigators that regularly travel to the field, in accordance with the Pre-Trial Chamber's jurisprudence on Rule 81(2) of the Rules of Procedure and Evidence (Rules). Equally, discrete redactions have been applied to protect the identity of Prosecution witnesses and sources under Rule 81(4) of the Rules.
