The Registrar of the International Criminal Court (the “Court”);

NOTING Trial Chamber III’s decision notified on 10 November 2010 authorizing the Registry to appoint two common legal representatives from the Central African Republic to represent the totality of the victims allowed to participate in the present case;¹

NOTING the Registrar’s filing notified on 18 November 2010 designating Mr Assingambi Zarambaud and Ms Marie Edith Douzima Lawson as legal representatives for all victims participating in the present case;²

NOTING Trial Chamber III’s decision notified on 12 March 2012 granting participating status to 457 applicants (the “Decision of 12 March 2012”);³

NOTING Trial Chamber III’s decision notified on 5 November 2012 granting participating status to 777 applicants (the “Decision of 5 November 2012”);⁴

NOTING article 68(1) of the Rome Statute; rules 90(2) to 90(5) of the Rules of Procedure and Evidence and article 16 of the Code of Professional Conduct for Counsel;

CONSIDERING that no conflict of interest has so far arisen in the representation of victims allowed to participate in the present case and that article 16 of the Code of

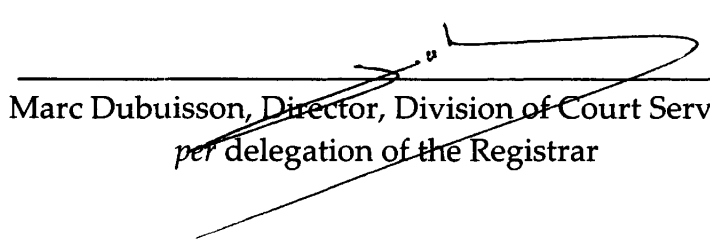
