1. In accordance with Rule 132(2) of the Rules of Procedure and Evidence a status conference shall be held on 14 February 2013 starting at 14.30. The main purpose of the status conference is to discuss the conditions of the summonses to appear issued by the Pre-Trial Chamber,¹ as well as to address any practical, financial and/or legal matters related to the attendance of the accused at trial, including the modalities of the accused's stay on the territory of the Host State during the trial. Given that these issues impact directly on the accused, the Chamber considers this to be a hearing requiring the accused's attendance and the accused are ordered to attend the status conference, either in person or via video link. An agenda for the status conference will be issued after the Chamber has received the submissions requested in its Order for observations on issues related to the commencement of trial.²

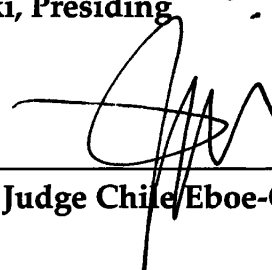
