NOTING the *“Defence Response to the Prosecution’s Application of Evidence from the Bar Table”* dated 19 March 2012 (the “Defence’s Response”);²

NOTING the *“Prosecution’s Reply to “Defence Response to the Prosecution’s Application for Admission of Evidence from the Bar Table””,* dated 30 March 2012 (the “Prosecution’s Reply”);³

NOTING the Trial Chamber III (the “Chamber”)'s *“Decision on the Prosecution’s Application for Admission of Materials into Evidence Pursuant to Article 64(9) of the Rome Statute”*, dated 6 September 2012 (the “Decision of 6 September 2012”);⁴

NOTING the Chamber’s *“Decision on the admission into evidence of items deferred in the Chamber’s “Decision on the Prosecution’s Application for Admission of Materials into Evidence Pursuant to Article 64(9) of the Rome Statute” (ICC-01/05-01/08-2299)”* (the “Decision of 27 June 2013”) and the *“Partly Dissenting Opinion of Judge Ozaki on the Decision on the admission into evidence of items deferred in the Chamber’s “Decision on the Prosecution’s Application for Admission of Materials into Evidence Pursuant to Article 64(9) of the Rome Statute”(ICC-01/05-01/08-2299)”*, dated 27 June 2013;⁵

NOTING article 64(9) (a) and (10) and 69 of the Rome Statute; rules 15, 63(2) and 64 of the Rules of Procedure and Evidence; regulations 28 and 53 of the Regulations of the Registry;

CONSIDERING that in its Decision of 27 June 2013, “[...] the Majority of the Chamber, Judge Kuniko Ozaki dissenting, ADMITS into evidence: ERN pages DRC-OTP-0100-0315 to DRC-OTP-0100-0348 of item DRC-OTP-0100-0314; item CAR-OTP-0011-0422; item CAR-OTP-0004-0577; and item CAR-OTP-0008-0409.”;⁶

CONSIDERING that the Chamber ordered “the EVD-T numbers previously assigned to the items admitted into evidence in the present decision shall remain unchanged”;⁷

CONSIDERING that the Chamber instructed the Registry “to assign new EVD-T numbers to those items which currently do not have EVD-T references”;⁸

CONSIDERING that the Chamber admitted into evidence only certain ERN pages from item DRC-OTP-0100-0314, namely DRC-OTP-0100-0315 to DRC-OTP-0100-0348;

INFORMS the Chamber that the EVD-T previously assigned to item DRC-OTP-0100-0314 is now assigned only to the admitted ERN pages DRC-OTP-0100-0315 to DRC-OTP-0100-0348;
