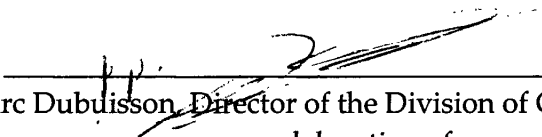
The Registry of the International Criminal Court (the “Court”);
