CONSIDERING the "Registry Transmission of documents received from the Republic of Burundi" submitted by the Registry on 11 September 2013;¹

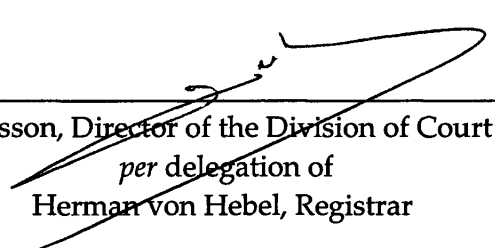
