NOTING the document entitled *"Mandat d'arrêt à l'encontre de Jean -Pierre Bemba Gombo, Aimé Kilolo Musamba, Jean-Jacques Mangenda Kabongo, Fidèle Babala Wandu et Narcisse Arido"* (the "Warrant of Arrest") rendered by the Single Judge on 20 November 2013;¹

NOTING the *"Decision setting the date for the first appearance of Jean-Pierre Bemba Gombo, Aimé Kilolo Musamba and Fidèle Babala, and on issues relating to the publicity of the proceedings"* rendered by the Single Judge on 25 November 2013;²

NOTING articles 89 and 91 of the Rome Statute, rules 117, 176(2) and 184 of the Rules of Procedure and Evidence and regulations 23bis and 24bis of the Regulations of the Court;

CONSIDERING that Mr. Jean-Pierre Bemba Gombo has been detained in the ICC Detention Centre since 3 July 2008;

CONSIDERING that the Registrar has ensured that Mr. Jean-Pierre Bemba Gombo received a file containing the Court's basic legal documents upon admission to the ICC Detention Centre on 3 July 2008 and that the procedure established pursuant to regulation 186 of the Regulations of the Registry was followed;

CONSIDERING that Mr. Jean-Pierre Bemba Gombo was notified with a certified copy of the Warrant of Arrest and provided with the list of counsel and the relevant

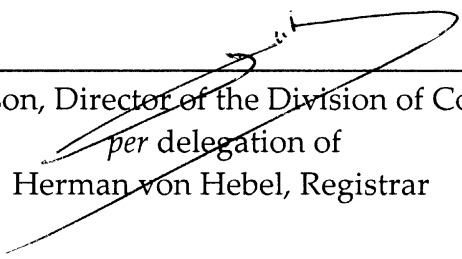

legal provisions³ on the 23 November 2013 at 09.28 hours, as the remaining legal text had already been provided upon his admission to the ICC Detention Centre according to Regulation 186 (2)(b);⁴
