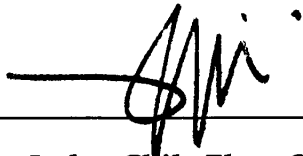
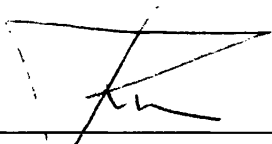
**Others**

1. **Trial Chamber V(A)** of the International Criminal Court, in the case of *The Prosecutor v William Samoei Ruto and Joshua Arap Sang*, pursuant to Rule 132(2) of the Rules of Procedure and Evidence, will hold a status conference on Wednesday, 15 January 2014, at 14:30.
