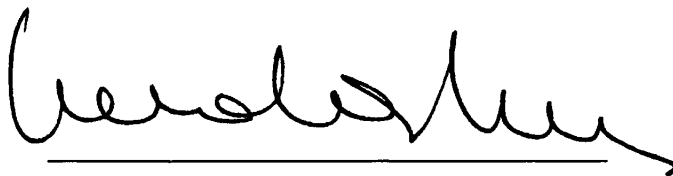

ORDERS the Prosecutor to file her response to the Request, if any, by Friday, 24 January 2014.
