Introduction

1. The Prosecution herewith submits its communication of the disclosure of materials falling within Rule 77 of the Rules of Procedure and Evidence.

Procedural background

2. On 28 January and 31 January 2014, the Prosecution filed its seventh and eighth applications for redactions to information in statements and documents to be disclosed under the provisions of Rule 77.¹
3. On 6 February 2014, the Single Judge issued the "Seventh Decision on the Prosecutor's requests for redactions" ("Seventh Decision"), authorising redactions to these materials and ordering the Prosecution to disclose them within 24 hours of the notification of her decision.²

Disclosure of evidence

4. On 7 February 2014, the Prosecution disclosed to the Defence the redacted materials that were the subject of the Single Judge's Seventh Decision, including 14 items collected pursuant to Article 54(3)(e) for which the provider has lifted the confidentiality restrictions. The Prosecution appends the total list of the evidence disclosed in Confidential Annex A.
