Pursuant to article 42 (8) of the Statute and rule 34 (2) of the Rules of Procedure and Evidence,

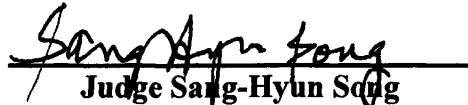
Issues the following
