NOTING the *"Mandat d'arrêt à l'encontre de Jean-Pierre Bemba Gombo, Aimé Kilolo Musamba, Jean-Jacques Mangenda Kabongo, Fidèle Babala Wandu et Narcisse Arido"*¹ ;

NOTING articles 43 and 67 (1) (d) of the Rome Statute, rules 20, 21 and 22 of the Rules of Procedure and Evidence, regulations 23bis, 67, 73, 77 (4) (e) and 77 (5) of the Regulations of the Court;

INFORMS respectively the Single Judge of Pre-Trial Chamber II (the "Chamber") as follows:

1. Pursuant to regulation 73 (4) of the Regulations of the Court, the Registrar has appointed Mr Xavier-Jean Keïta, principal counsel of the Office of Public Counsel for the Defence, as duty counsel to assist and represent the interests of Mr Narcisse Arido immediately before, during and immediately after his first appearance before the Chamber.
2. The Registry informs the Chamber that Mr. Keïta has executed the undertaking required by article 5 of the Code of professional conduct for counsel (ICC-ASP/4/32) on 22 October 2007².
3. The representatives of the Counsel Support Section shall meet Mr Arido as soon as practicable after his arrival to the custody of the Court to inform him of his rights regarding assistance by counsel³. The Counsel Support Section shall notify the Chamber as soon as Mr Arido notifies a choice of counsel.
4. The document is filed confidentially because the information on the imminent transfer of the suspect to the custody of the Court is not yet in the public

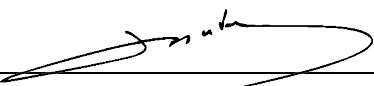
