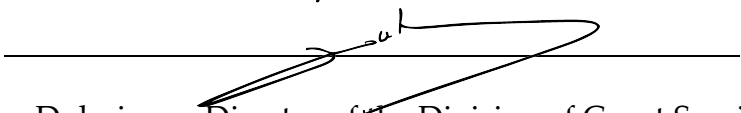
NOTING the “Decision convening a hearing for the first appearance of Narcisse Arido” rendered by the Single Judge on 18 March 2014;²
