The Appeals Chamber of the International Criminal Court,

In the appeal of Mr Thomas Lubanga Dyilo against Trial Chamber I's decision entitled "Judgment pursuant to Article 74 of the Statute" of 14 March 2012 (ICC-01/04-01/06-2842),

In the appeals of Mr Thomas Lubanga Dyilo and the Prosecutor against the decision of Trial Chamber I entitled "Decision on Sentence pursuant to Article 76 of the Statute" of 10 July 2012 (ICC-01/04-01/06-2901),

Recalling the "Scheduling order for a hearing before the Appeals Chamber" of 21 March 2014 (ICC-01/04-01/06-3067), in which the Appeals Chamber: 1) announced that a hearing would be held on Monday, 14 April 2014, and Tuesday, 15 April 2014, for the purposes of hearing the testimony of witnesses D-0040 and D-0041, as well as to receive submissions and observations by the parties and participants, and 2) instructed the Registrar to make all the necessary arrangements for the hearing of the two witnesses and to inform the Appeals Chamber immediately if any difficulties were encountered that could affect the announced hearing schedule,

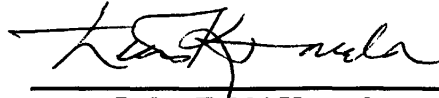
Noting the "Registry report to the Appeals Chamber in compliance with ICC-01/04-01/06-3067", filed on 1 April 2014 and registered on 2 April 2014 (ICC-01/04-01/06-3075), in which the Registrar informed the Appeals Chamber that, for various logistical reasons, the "scheduled dates of 14 and 15 April are not attainable" for the purpose of hearing the two witnesses,
