I. Introduction

1. The Office of the Prosecutor ("Prosecution") hereby notifies the Single Judge of the Prosecution's Urgent Further Request for Disclosure of Evidence in a Related Article 70 Proceeding before Trial Chamber III ("Request"), pursuant to that Chamber's 14 March 2014 Decision¹.

2. The Request seeks access to the transcripts of evidence of a limited number of Defence witnesses, as well as one court witness, and several confidential documents in the *Bemba* case to enable the Prosecution: (i) to rely on such evidence in its DCC and during the confirmation proceedings;² and (ii) fully to discharge its disclosure obligations as required by the Single Judge and in accordance with the Court's legal framework³.

3. The Request is attached to this notification as *Confidential* Annex A.

II. Confidentiality

4. This notification and Annex A are designated as "Confidential" because the submission in the *Bemba* case is so designated.
