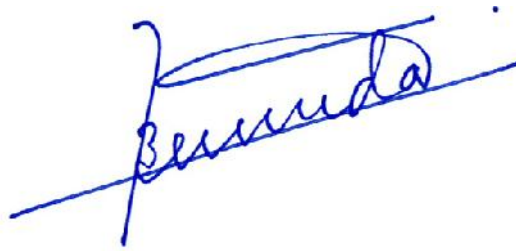

In keeping with prior practice to keep the Chamber informed of the execution of its disclosure obligations, and in accordance with the Chamber's "Order regarding redactions"¹, the Prosecution herewith submits its communication to the Defence of materials pursuant to the Trial Chamber order of 28 February 2014², potentially exculpatory evidence pursuant to Article 67(2) of the Rome Statute ("the Statute") as well as Rule 77 of the Rules of Procedure and Evidence ("the Rules").
