NOTING rule 13 (1) of the Rules of Procedure and Evidence and regulation 24*bis* of the Regulations of the Court;

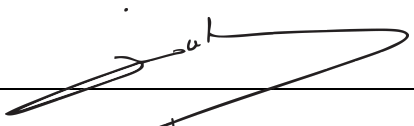
CONSIDERING that the Defence in case ICC-01/05-01/08 is neither a party nor a participant in case ICC-01/05-01/13;
