Noting its decision of 20 May 2014, entitled: Corrigendum to the “Decision on the ‘Defence application to the Presidency for judicial review of the Registrar’s second decision on legal assistance dated 27 February 2014’” (“Decision”);¹

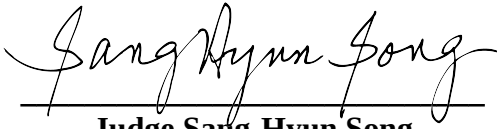
Considering that neither the Defence for the Suspect² nor the Registrar³ identified further confidential and *ex parte* material information in the Decision.
