I. Notification

1. Pursuant to Article 61(3) of the Rome Statute, Rule 120(3) of the Rules of Procedure and Evidence, and the 28 May 2014 Decision of the Single Judge,¹ the Prosecution hereby files² the Document Containing the Charges (“DCC”) attached at Confidential Annex B1. Its French translation is attached at Confidential Annex B2.

2. The Prosecution further attaches, at Confidential Annex C1, a graphic summary of the specific charged instances of the corrupt influencing of witnesses described at paragraphs 45 through 109 of the DCC. A French translation of this graphic summary is attached at Confidential Annex C2. Confidential Annex D comprises a list of the items specifically cited in the DCC. Finally, Confidential Annex E attaches the Prosecution’s List of Evidence.

II. Confidentiality

3. The DCC and all of its annexes are filed as “Confidential” because they refer to material that is sensitive and otherwise unavailable to the public as yet.
