Judge Ekaterina Trendafilova, acting as Single Judge on behalf of Pre-Trial Chamber II (the “Chamber”) of the International Criminal Court,¹ hereby notifies the parties in this case of two redacted versions of decisions which had been originally issued by Pre-Trial Chamber I.

1. On 16 January 2014, the Single Judge issued the “Decision on the Reclassification of Documents” (the “16 January 2014 Decision”)² in which she indicated that a redacted version of decisions contained in ICC-01/04-02/06-1-US-Exp and ICC-01/04-108-Conf-Exp (which in the case record carries the document number ICC-01/04-02/06-214-Conf-Exp) would be issued in due course. The justification for the redactions to be applied or retained has been provided in the 16 January 2014 Decision.

2. The Single Judge notes articles 57(3)(c), 67 and 68(1) of the Rome Statute, and rules 15, 81, 121(10) and 129 of the Rules of Procedure and Evidence.

3. The confidential redacted version of the decision of Pre-Trial Chamber I entitled “Decision on the Prosecution Application for a Warrant of Arrest” dated 22 August 2006 (ICC-01/04-02/06-1-US-Exp), is attached as Annex A1 (French) and A2 (English) to the present decision and can be made available to the Defence on a confidential basis.³

4. The confidential redacted version of the decision of Pre-Trial Chamber I entitled “Decision concerning the Hearing on 2 February 2006” dated 31 January 2006 (ICC-01/04-02/06-214-Conf-Exp) is attached as Annex B1 (English) and B2 (French) to the present decision and can be made available to the Defence on a confidential basis.⁴

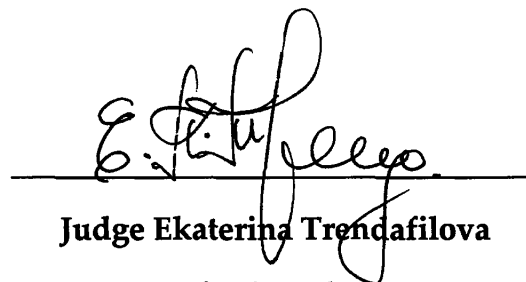
