NOTING the Chamber’s *“Decision on the “Prosecution’s Request for Reclassification of 15 admitted Documents as Public and for Application of Redactions”*¹ dated 17 June 2014 (“Decision 3092”);

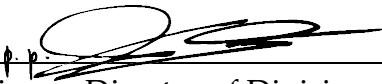
