The Registrar of the International Criminal Court (the “Court”);

NOTING the Decision on reclassification of certain documents notified on 4 July 2014 (the “Decision”),¹ whereby the Single Judge of Pre-Trial Chamber II (the “Pre-Trial Chamber”) ordered the Registrar to prepare public versions with redactions to the extent necessary, as the case may be, of seven documents emanating from the Registry and previously notified with a confidential or confidential *ex parte* status (the “Documents”);²

NOTING the Decision notified on 18 July 2014, whereby, following a decision of the Pre-Trial Chamber to confirm the charges against Mr. Bosco Ntaganda,³ the Presidency constituted Trial Chamber VI (the “Trial Chamber”) and referred to it the case of *The Prosecutor v. Bosco Ntaganda* (the “Case”);⁴

NOTING article 68 (1) of the Rome Statute and regulation 25 (1) and (2) of the Regulations of the Registry;

CONSIDERING that the Documents to be reclassified are: (1) the Registry’s interim report on the organisation of common legal representation for the victims in the Case, notified on 13 November 2013;⁵ (2) the six reports to the Pre-Trial Chamber on

applications to participate in the proceedings in the Case, notified from September 2013 to January 2014;⁶

CONSIDERING that the Registry has 1) identified certain information in all the Documents which in view of the Registry could lead to the identification of victims participating in the proceedings or of third persons involved if known by the public; 2) prepared consequently a public redacted version for all the Documents by applying limited redactions in compliance with the Decision;⁷

INFORMS the Trial Chamber that pursuant to the Decision the Registry hereby submits a public redacted version of the following documents in the Case file:
