I, Judge Cuno Tarfusser, having been designated as Single Judge of Pre-Trial Chamber II of the International Criminal Court;

NOTING the “Enregistrement de la déclaration d’acceptation de désignation signée par Maître Ghislain Mabanga Monga Mabanga en qualité de conseil de M. Aimé Kilolo Musamba, et des engagements du conseil prévus aux article 5 du Code de conduite professionnelle des conseils” dated 21 January 2014¹;

NOTING the “Requête aux fins d’obtenir autorisation de retrait en qualité de Conseil principal de la Défense de M. Aimé Kilolo Musamba (Norme 78-1 du Règlement de la Cour)” dated 14 August 2014 (“Request”)², whereby the Defence counsel for Aimé Kilolo Musamba informs the Chamber that his mandate has been terminated by his client and, accordingly, requests leave to withdraw from the present case “avec effet immédiat”;

NOTING the “Annexe 1 confidentielle” at the Request, dated 13 August 2014, whereby Aimé Kilolo Musamba declared, in a signed manuscript paper, the termination of the mandate of Ghislain M. Mabanga³;

NOTING the “Information of the Registrar in relation to the designation of Mr. Paul Djunga by Mr. Aimé Kilolo Musamba” (“Registrar’s Information”)⁴, whereby the Registrar “informs the Chamber of the steps taken by the Registrar in respect of the communications sent by Mr. Aimé Kilolo Musamba on 13 August 2014 regarding his legal representation” and of the appointment of Paul Djunga Mudimbi as the new counsel of Mr Kilolo;

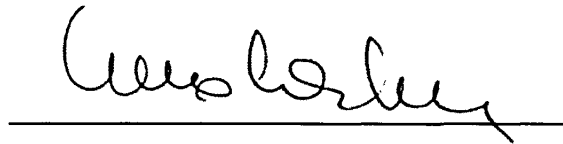
CONSIDERING that, as stated in the Registrar's Information, the appointment of the new counsel will be effective from the moment of the issuance of this decision;
