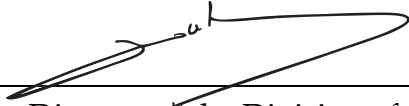
NOTING the Notification to the Defence and the Legal Representatives of the Applicants of redacted versions of applications for reparation pursuant to rule 94(2) of the Rules of Procedure and Evidence (the “Rules”), notified on 28 October 2013;¹

NOTING the instruction of Trial Chamber III (the “Chamber”), conveyed by email of 11 May 2012, that the Registry should notify the applications for reparations notified to the Defence under Rule 94(2) of the Rules also to the legal representative designated in the application form or, in case no legal representative is designated, the Office of Public Counsel for Victims (the “OPCV”);²

CONSIDERING that applicants a/05158/12 and a/05163/12 who applied for participation in the proceedings and for reparations designated the late Me. Zarambaud as legal representative;

CONSIDERING that following the passing of the late Me. Zarambaud, applicants a/05158/12 and a/05163/12 are unrepresented applicants, who should now be represented by the OPCV, in accordance with the aforementioned instruction of the Chamber of 11 May 2012;

NOTIFIES the Chamber, the parties and the participants that the OPCV represents applicants a/05158/12 and a/05163/12.
