NOTING rule 13(1) of the Rules of Procedure and Evidence, regulation 24*bis* of the Regulations of the Court;

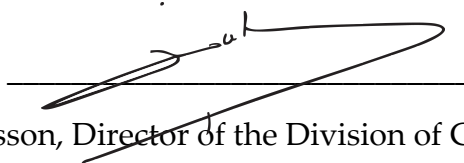
CONSIDERING that the Defence Team for Mr. Narcisse Arido is neither a party nor a participant in the present case;
