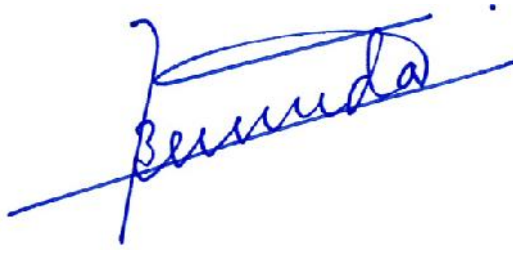

1. The Office of the Prosecutor (“Prosecution”) submits this second updated list of relevant decisions, orders and transcripts of the Court, and electronic copies of authorities (internet links) that it anticipates it may use at the appeal hearing.¹ This second updated list is filed, exceptionally, to take into account the Appeals Chamber’s recent order concerning reclassification.² The list continues to be provisional—the Prosecution may refer to additional documents from the trial record and authorities during the hearing, depending on the responses of the other parties and participants, and questions from the Chamber.
2. To assist the Appeals Chamber in referring to authorities actually cited, the Prosecution will submit written copies of its submissions prepared for the hearing—with appropriate references—once counsel have finished speaking.
3. The Prosecution files the attached annex confidentially, pursuant to Regulation 23*bis* of the Regulations of the Court (“RoC”), as it refers to documents which are still confidential.³
