THE REGISTRAR of the International Criminal Court (the ‘Court’);

NOTING the *“Prosecution’s request for materials related to P-0800 to be admitted into evidence and assigned evidence (EVD) numbers”* (“the Prosecution Request”) and its confidential annex A dated 26 November 2014¹;

NOTING the *“Ruto Defence request for materials related to Witness P-0800 to be accepted into evidence and assigned evidence (EVD and MFI) numbers”*² (“the Ruto Defence Request”;

NOTING the *“Decision on the Prosecution and Ruto Defence Requests for Materials Related to P-0800 to be Admitted into Evidence and Assigned evidence (EVD and MFI) Numbers”*³ (the “Decision”) issued by Trial Chamber V(A) (the “Chamber”) on 18 December 2014;

NOTING articles 64(9)(a) and (10) and 69 of the Rome Statute; rules 15, 63(3) and 64 of the Rules of Procedure and Evidence; regulation 23bis(2) of the Regulations of the Court; regulations 28 and 53 of the Regulations of the Registry;

CONSIDERING that the Chamber directed the Registry “to assign the Proposed Exhibits as listed in paragraphs 3 and 4, and specified in paragraph 8 of the Decision an EVD number”⁴;

CONSIDERING that the Chamber also directed the Registry “to assign the Ruto Defence Materials listed in paragraph 5 and specified in paragraph 8 of the Decision, (...) an MFI number”⁵;

CONSIDERING that the Chamber directed “the Registry to confirm these numbers have been assigned via a written filing”⁶

INFORMS respectfully that EVD-T-OTP numbers have been attributed to the 9 items admitted into evidence listed in Annex A of the Prosecution Request;

INFORMS respectfully that EVD-T-D09 numbers have been attributed to the 8 items admitted into evidence listed in the Ruto Defence Request; and

INFORMS respectfully that MFI-T-D09 numbers have been attributed to the 20 items marked for identification listed in the Ruto Defence Request;

SUBMITS as an annex to this report a table recapitulating the relevant information of the items admitted into evidence and marked for identification;
