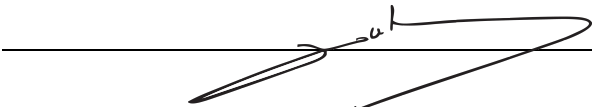
NOTING the Oral Order issued by Trial Chamber V (A) (the “Chamber”) on 22 January 2015;¹
