INFORMS respectfully that EVD-T-D09 numbers have been attributed to the items admitted into evidence;

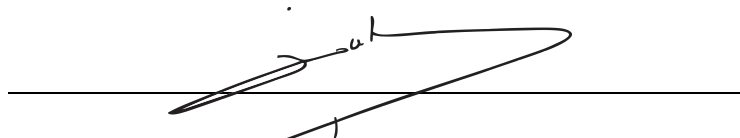
