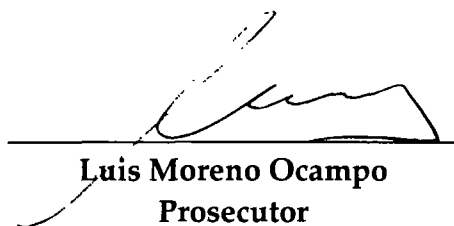
Prosecutor's Request for a Postponement of the Status Conference Convened by the Pre-Trial Chamber in its 2 December 2005 Decision to Convene a Status Conference on the Investigation in the Situation of Uganda in Relation to the Application of Article 53

1. The Pre-Trial Chamber has scheduled a status conference to be held on 14 December 2005 “with a view to considering the status of the investigation in the situation of Uganda in relation to the application of Article 53”.¹ The Prosecutor will be absent from office between 12 December 2005 and 16 December 2005 for the purposes of reporting to the U.N. Security Council on the progress of the Darfur investigation on 13 December 2005, and conducting other important meetings related to the Darfur investigation prior to and after the Security Council briefing.
2. The Prosecutor considers that his personal appearance is required due to the importance of the issues at bar and the fact that certain public statements made by him have been registered into the record by the Chamber and considered for the purposes of convening the status conference.² Therefore, the Prosecutor respectfully requests that the status conference be postponed. The Prosecutor suggests that the conference be held as soon as possible after the end of the year 2005 judicial recess.
