THE REGISTRAR of the International criminal Court (the “Court”)

NOTING the “*Decision on Prosecution requests to join the cases of The Prosecutor v. Laurent Gbagbo and the Prosecutor v. Charles Blé Goudé and related matters*”,¹ (the “Decision”) issued by the Trial Chamber I (the “Chamber”) on 11 March 2015;

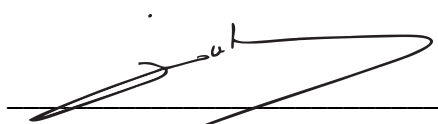
